Due to the changes with the passing of the Election Integrity Act of 2021, Absentee by Mail voting and Dropbox requirements has changed.

**TO REQUEST AN ABSENTEE BALLOT:** Voters can begin now to apply for absentee ballots by mail for the November 8, 2022 General/Special Election. Applications can only be accepted between 78 and 11 days before an election. Note: The deadline for voters to request an absentee ballot for the November 8, 2022 General Election is **October 28, 2022**. **Please contact our office – 478-934-3200 ext. 8 for questions.**

- Dropbox Hours and closures: The dropbox will be made available only during the hours of advance voting period – October 17, 2022 until November 4, 2022 8:30 a.m. – 5:00 p.m.  
Monday – Friday. Saturday Voting – October 22 & October 29 – Hours: 9:00 a.m. – 5:00 p.m.

**Note: The dropbox shall be closed when the advance voting period ends.**
